Solano Land Trust (SLT) has taken enhanced health and safety measures – for you and other attendees. Your health and well-being is always paramount to Solano Land Trust. It is requested, and all Attendees are expected to, follow all posted instructions while attending this event.

An inherent risk of exposure to COVID-19 exists in any public place where people are present. Your participation in this event brings some risk, and SLT wants the Attendees to agree to follow all Center for Disease Control and Prevention (CDC) guidance related to Planning Safe Events and Participating in Outdoor and Indoor Activities. 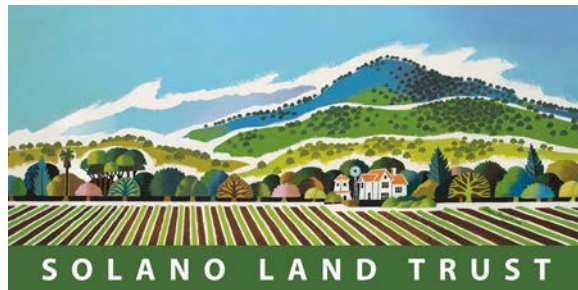

In coordination with the recommended protocols, SLT will be adhering to the following:

- a. Email and U.S. Mail communications will ask anyone who may not be feeling well or has been in contact with someone infected with COVID-19, to stay home.
- b. All SLT volunteers, staff and board member's protocol will be to wear masks at all times except when they are speaking on the microphone or eating, for both their, and your, health and safety. All attendees are encouraged to follow the same protocol, based on your personal comfort level.
- c. All attendees are asked to be respectful of other attendees' comfort level by practicing social distancing.
- d. Auction tables, wine reception, and dinner tables will be set-up in accordance with social distancing guidelines.
- e. Increased hygiene/sanitation measures will be instituted.
- f. Email address and/or phone number of each attendee will be required for contact tracing, if needed.
- g. Accommodations for people who are not comfortable with the in-person event, but still want to participate, will be provided.

You will find attached a COVID-19 Waiver of Liability and Hold Harmless Agreement that is a document intended to acquire the consent of our Attendees. This legal document is intended to reduce the number of unnecessary lawsuits, if not to eliminate them through your education about the risks involved in your participation in this event, that may lead to injuries or death due to COVID-19. This liability release waiver will help explain the risks involved, and therefore, can let you discern whether you are still willing to proceed. By assuming the risks involved, this helps relieve Ethel Hoskins and The Joyful Ranch Foundation and Solano Land Trust from any liabilities that may arise.

We at Solano Land Trust want to thank you in advance for your continued support and cooperation. We recognize this protocol and process is a cautiously protected approach, but know that each of you appreciate these safety precautions for everyone's continue well-being.



WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

The World Health Organization has declared the novel Coronavirus (COVID-19) a worldwide pandemic. Due to its capacity to transmit from person-to-person through respiratory droplets, the government has set recommendations, guidelines, and some prohibitions which SOLANO LAND TRUST adheres to comply. Our organization is taking extra precautions with the care of every attendee, to include enhanced CDC sanitation/disinfecting procedures.

In consideration for receiving permission to be on the premises of ETHEL HOSKINS AND THE JOYFUL RANCH FOUNDATION to attend the SOLANO LAND TRUST SUNDAY SUPPER, I hereby acknowledge and agree to the following:

1. I understand the hazards of the novel coronavirus ("COVID-19") and am familiar with the Centers for Disease Control and Prevention ("CDC") guidelines regarding COVID-19. I am aware that COVID-19 is an extremely contagious virus and that it is currently believed to spread through person-to-person contact. I acknowledge and understand that the circumstances regarding COVID-19 are changing from day to day and that, accordingly, the CDC guidelines are regularly modified and updated. I accept full responsibility for familiarizing myself with the most recent updates, as well as making informed choices to take precautionary measures to protect myself and others.
2. Notwithstanding the risks associated with COVID-19, which I readily acknowledge, I hereby willingly choose to participate in Activities.
3. In addition to the CDC guidelines, I agree to abide by any and all policies or posting published to the general public at the Facility.
4. I acknowledge and fully assume the risk of illness or death related to COVID-19 arising from my being on the premises and participating in the Solano Land Trust Sunday Supper and hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE Ethel Hoskins and the Joyful Ranch Foundation and/or Solano Land Trust, their principals, agents, shareholders, officers, owners, directors, employees, affiliate companies, attorneys, representatives, insurers, successors and assigns, and/or any vendor providing goods or services to the Solano Land Trust Sunday Supper (hereafter collectively referred to as "RELEASEES") from any liability related to COVID-19 which might occur as a result my being on the premises and participating in the Solano Land Trust Sunday Supper.

5. I shall indemnify, defend and hold harmless the RELEASEES from and against any and all claims, demands, suits, judgments, losses or expenses of any nature whatsoever (including, without limitation, attorneys' fees, costs and disbursements, whether of in-house or outside counsel and whether or not an action is brought on appeal or otherwise), arising from or out of, or relating to, directly or indirectly, the infection of COVID-19 or any other illness or injury.

6. It is my express intent that this Waiver and Hold Harmless Agreement shall bind any assigns and representatives, and shall be deemed as a RELEASE, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE the above-named RELEASEES. This Agreement and the provisions contained herein shall be construed, interpreted and controlled according to the laws of the State of California. I hereby knowingly and voluntarily waive any right to a jury trial of any dispute arising in connection with this agreement. I acknowledge that this waiver was expressly negotiated and is a material inducement for the permission granted by releasees to be on premises and participate in the Solano Land Trust Sunday Supper.

IN SIGNING THIS AGREEMENT, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Wavier of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Agreement for full, adequate and complete consideration fully intending to be bound by same.
